## **Agenda Items**

#### 1. Discussion on Insurance Scott Schultz

#### Discussion:

- Our insurance is finalized, covered through a company called Pearson Dunn (Hamilton ON). This company also does the insurance for the Ontario BJJ Federation
- Pearson Dunn Specializes in sports
- It has been recommended by Pearson Dunn that we sanction tournaments in writing. For every event, we must provide the Certificate and a letter of exactly what is being sanctioned.
- Members of the SBJJF are covered by this insurance for any sanctioned event as well as non-sanctioned events in Canada.
- We will need to put a letter together to go out to membership stating that you must notify the SBJJF for any out of province travel, should you require the insurance to follow.
- For members going to the United States and elsewhere, they are required to contact Pearson Dunn and pay a nominal fee (\$4 a day) for the insurance to follow them. The liability would not follow but accident and sickness would.
- If we are entertaining insurance for out of province events.
- For sanctioned events it's recommended that we put together a tournament manual so there are standards. Ex. cleaning the mats before and after event to prevent ringworm, how to handle ringworm etc.

## **Action Items**

Scott to get a copy of the certificates to provide to sanctioned events. Adam to go over wording on insurance coverage.

## 2. Policy Update to Club Members and Event Organizers

## Discussion:

- Sasksport has been contacted (By AJ) and received a clear definition on how we should create our organization.
- To encourage membership and exclude, a club member can be non-profit or for-profit the membership prices are reflected in this. Non-Profit \$250.00 and Profit \$350
- Sasksport/Amateur sport is promoting non-profit, because of this all event coordinators are required to be non-profit club members.

## **Motions**

Adam moves that we update Section 6 and 7 in the policy to make it clearer, who is considered and adult membership. It should read 18 years and older.

## 3. Financials Update

#### **Discussion:**

- 3 tournament sanctions have been paid in full. These include the, Western Kids (Regina), CopaSask (Regina) and the Queen City Open (Rgina)
- At this time there is \$2850.00 in the bank account once the paypal account money has been transferred, there will be approx. \$3545.00 in the account.

- AJ and Rod have signing authority for SBJJF; we will need to get two more in addition to the treasurer.
